Project Evaluator

Description: Expertise in research methodology, program evaluation and statistical analysis. Responsible for the identification of evaluation targets and the design and/or selection of data collection instruments required to assess those targets. Able to translate program data into meaningful reports and able to effectively communicate evaluation findings to interested stakeholders.

Minimum Experience: 5 years of hands-on experience in the design of evaluations and analysis of data. Experience in conducting cost-benefit analyses.

Minimum Education: Ph.D. from an accredited college or university in Measurement, Research Design, Education, Business Administration, or related field.

Business Process Specialist

Description: Expertise in integration and application of assessment material to meet organizational needs. Consults with client organizations to improve efficiency and productivity of the assessment and the use of assessment results. Able to complete cost-benefit analyses and demonstrate the relative costs of different approaches to conducting an assessment program.

Minimum Experience: 3-5 years of progressively responsible management experience in an assessment related environment, with a emphasis on accounting issues.

Minimum Education: M.A. in Organizational Psychology, Business Administration or experience resulting in comparable knowledge and skills.

Content Area Specialist

Description: The Content Area Specialist will work with other senior staff to lead the test development process. This position will supervise the development of blueprints and test specifications; manage test item pools and create production plans; review and approve the selection of literary and informational passages and artwork for test use; write, review, and revise test items based on their fairness and content; lead group review sessions; resolve team and client feedback on test items at individual meetings and group review sessions; recruit, train, and manage internal and external item writers; review and approve training materials for item writers; review and approve test item pools; lead client committee meetings in which stakeholders review the fairness and content of test items; and assemble field test and operational test forms.

Minimum Experience: Candidates must have at least six years of professional experience working in education or educational measurement. A demonstrated ability to identify problems and conceptualize solutions, prioritize tasks and meet deadlines, and work collaboratively with others.

Minimum Education: A B.A. in Education or a related field is required. A M.A. in Education is preferred. An equivalent combination of education and experience resulting in comparable subject area expertise is acceptable.

Training Manager

Description: Responsible for the planning and implementation of assessment-related training. Especially training related to test administration, the interpretation of assessment results, and the application of assessment results to improve curriculum and instruction.

Minimum Experience: 3-5 years of training experience in an education environment with a background in assessment.

Minimum Education: B.A. in Education or Business or an equivalent combination of education and experience resulting in comparable expertise is acceptable.

Project Manager

Description: Responsible for the planning, implementation, and monitoring of project tasks required to successfully achieve project outcomes. Coordinates the actions of project team members and provides input regarding policy, personnel, procedures, and project requirements.

Item Writer

Item content covers specific curricula frameworks, standards, and specifications as dictated by project requirements.

Minimum Experience: 2 - 3 years of assessment development experience.

Minimum Education: B.A. from an accredited college or university in the content area for which they are assigned to write items.

Editor/Proofreader

Description: The focus of this position is on the written word, whether presented in print or electronic format. Various aspects include copy matching, production editing, development editing, and copyediting. Areas of attention include test forms and associated materials, new test items, and materials generated by program management and marketing.

Minimum Experience: 2 - 5 years of proofreading or editorial experience in education or publishing.

Minimum Education: B.A. from an accredited college or university in Education, English, Communication, or comparable experience in professional setting.

Data Capture Specialist
